MGE'S NOTICE OF SATISFACTION

COMES NOW Missouri Gas Energy, a division of Southern Union Company ("MGE"), and respectfully states the following to the Missouri Public Service Commission ("Commission") as its Notice of Satisfaction:

- 1. On November 19, 2007, Percy Cannon (Mr. Cannon or Complainant) filed a Complaint with the Commission against MGE. Mr. Cannon alleged that he had been wrongfully denied gas service at 3223 E. 41st Street, Kansas City, MO. On November 26, the Commission issued notice of the complaint and directed that MGE file its response by December 26.
- 2. Since that time, service was initiated at Mr. Cannon's address (3223 E. 41st Street) after MGE reached an accommodation with the Cannons concerning the debt owed by Mr. Cannon's spouse, Swanita M. Carson-Cannon. *See MGE's Notice Concerning Natural Gas Service*, filed December 5, 2007.
- 3. The Complaint also alleged that MGE was seeking recovery from Mr. Cannon of debts related to other referenced addresses (4542 Park and 3009 E. 27th Street). In light of the accommodation that has been reached at 3223 E. 41st Street, MGE will no longer seek to recover

from Mr. Cannon the debts related to 4542 Park and 3009 E. 27th Street, if this will satisfy the Complaint. MGE will make appropriate entries in its billing system to disassociate Mr. Cannons' name from the debts at those addresses.

4. MGE believes that these actions will satisfy Mr. Cannon's Complaint and that the Complaint will be moot.

WHEREFORE, Respondent Missouri Gas Energy prays the Commission consider this Notice of Satisfaction and, thereafter, dismiss the Complaint.
