# **NOTICE OF COMPLIANCE**

Missouri Joint Municipal Electric Utility Commission ("MJMEUC"), for its Notice of Compliance to the Missouri Public Service Commission ("Commission") states as follows:

- 1. On February 9, 2022, the Commission issued its Order Approving Application to Transfer Assets and Granting Waiver in the above referenced File, which took effect on March 11, 2022. In its Order, the Commission granted GridLiance High Plains, LLC ("GridLiance") authority to sell and transfer to MJMEUC approximately ten miles of 69 kV electric transmission lines and related facilities located in Christian and Greene Counties in Missouri, and upon the closing of the transaction, cancelled GridLiance's filed tariffs.
- 2. Pursuant to paragraphs 4 and 5 of the Order, GridLiance and MJMEUC shall provide the Commission with a final bill of sale reflecting the net book value of the sale assets and MJMEUC shall provide the Commission with official documents regarding contracts for ongoing maintenance of the facilities with the City of Nixa.
  - 3. On or about May 31, 2022, the transaction closed.
- 4. In compliance with paragraphs 4 and 5 of the Order, MJMEUC submits the following documents attached hereto as Exhibits A and B:
