NOTICE OF CORRECTION


COMES NOW the Staff of the Commission (Staff) and for this Notice of Correction respectfully states:

1. On January 25, 2001, Staff filed its Final Electric Incident Report in this case.
2. By mistake, the Staff attached and filed an incorrect Appendix E in the original Commission casepapers. The copies filed with the Commission, and those served on the parties, had the correct Appendix E. Attached for filing is the correct version of the Kansas City Power & Light Company (KCPL) Boiler Explosion Investigation Report (KCPL Report) that should be substituted for the incorrect version of the KCPL Report that is attached at Appendix E of the HC version of Staff's Final Report concerning the Hawthorn 5 boiler explosion.


