



Dear Commissioner:

As an employee of Missouri Public Service, when you are voting on the merger between KCPL and Aquila, please consider a few things which were kept from you and your staff in the recent hearings. I would love to identify myself but I can't because I have no better opportunity than to work for KCPL when the takeover is complete, and it is pretty well known that an Aquila corporate employee who testified in a way that KCPL did not like had his offer "adjusted".

Many employees of our company take great pride in the work that has been done over the last few years to bring Aquila back. In fact, we learned that we would have been investment grade in 2009 if we had taken some planned steps that KCPL did not allow us to because they wanted to take credit for that. Even so, we still would be investment grade in 2010 if we did not merge. KCPL management has proven they are very arrogant – it is their way or the highway. I read where some commissioners were afraid that if KCPL did not take us over that some out of town utility would. When the Chairman of the Board commutes in from North Carolina every week and the President of KCPL flies in from Chicago, how much more out of town can you get? They don't care about our community, our employees or much of anything else other than putting a feather in their own caps. They award themselves bonuses for having Iatan done on time and budget even when everyone knows it is not. I am scared that KCPL is going to come on rough times and when they do, they will start to cut costs and the first costs they cut will be our employees.
