ORDER DIRECTING FILING

On July 21, 1999, Union Electric Company, doing business as AmerenUE (UE), filed its application for findings by the Commission under 15 U.S.C. § 79z-5a(c), the Public Utilities Holding Company Act (PUHCA), relating to Exempt Wholesale Generators. UE's application was accompanied by a motion for expedited treatment; UE seeks an answer within 90 days. In its response, Staff shall indicate the earliest date on which it believes it will be able to recommend whether or not the relief sought by UE should be granted.

- 1. That the Staff of the Missouri Public Service Commission shall, on or before July 30, 1999, file its response to the Motion for Expedited Treatment filed herein by Union Electric Company, doing business as AmerenUE.
- 2. That in its response, the Staff of the Missouri Public Service Commission Staff shall state the earliest date on which it

believes it will be able to recommend whether or not the relief sought by Union Electric Company, doing business as AmerenUE should be granted.

3. That this order shall become effective on July 27, 1999.
