Hi! Thank you very much for giving us the opportunity to voice our opinion on the rate increase matter. I would like to preface my concern over the tremendous rate increase proposal with a few comments. I have been a resident of the Lake St. Clair development since 1999. Since then I have experienced very low water pressure (24/7), air in the system for no apparent reason on numerous occasions, and complete loss of water up to 2 days at a time without notice (summer months). I also have issue with teenagers (they look to be between the ages of 11-14 years of age) driving around on golf carts reading the meters. I have no proof they are reading the meters incorrectly, however I question the validity. I have also spoken to individuals in other counties including St. Louis County-they were shocked at our high rates. I do not oppose a reasonable rate increase because proper maintainance cannot be maintained at the current rate-however it seems very steep. When I moved in a \$400 hook up fee had to be paid as well. What was that money to be used for? Please know I want to be reasonable and trust you to make a fair assessment of this matter.

Also, I don't know how to put this in any other terms, but please do not let them (Mrs. Falkenberry)-I think that's her name, get wind of me expressing these issues personally. I hope this will be kept in strict confidence. I would not mind speaking with any of your representatives about this matter privately. I am just a little frightend of the backlash my opinion might cuase. I attended one community meeting and didn't go back. It was truly like the Jerry Springer Show. Old men were threatening to fight physically!! I was shocked. So I really try to keep to myself when it comes to matters dealing with the community-not knowing who might become angry over an opinion. 1) We are currently charged a "Monthly Customer Charge", the purpose of which has not been explained to customers.

2) When needed a company spokesperson is seldom available.

3) Our meter is generally read by a boy who could only be 10-12 years old. He is allowed to read the meters by himself, which is a safety concern to all the residents of Lake St.Clair.
