**NOTICE OF CLOSING**

COMES NOW Highway H Utilities, Inc. (Highway H), and, as its Notice of Closing, states the following to the Missouri Public Service Commission (Commission):

1. On April 11, 2012, the Commission issued its Order Approving Transfer of Assets.

Among other things, the Order directed as follows:


- Highway H Utilities, Inc. shall submit notice to the Commission regarding evidence of the transfer of assets to the City of Waynesville within three (3) business days after the transfer to the City of Waynesville;
- Highway H Utilities, Inc. shall file all necessary revisions to its tariff on file, including, but not limited to, 1st Revised Sheet No. 3 and Original Sheet No. 2A, to exclude entirely from its tariff the area being served by the water assets identified herein within five (5) business days after the assets have been transferred to the City of Waynesville

2. The transfer that is the subject of this case was completed on May 23, 2012.

3. Highway H has this date filed the tariff sheets provided herewith as **Appendix A** (Tracking No. YW-2012-0765) in order to exclude the Hunter's Pointe water system from the area being served by Highway H.

WHEREFORE, Highway H respectfully requests that the Commission find this Notice of Closing to comply with its Order Approving Transfer of Assets and issue such orders as it shall find to be reasonable and just.
