SECOND MOTION TO EXTEND PROCEDURAL SCHEDULE

Comes now Southern Union Company d/b/a Missouri Gas Energy ("MGE" or "Company"), and, as its Second Motion to Extend Procedural Schedule, states as follows to the Missouri Public Service Commission ("Commission"):

1. The Commission previously extended the procedural schedule in this matter at the parties' request such that surrebuttal testimony and cross-surrebuttal testimony is due on February 27, 2012.

2. On February 16, 2012, MGE and the Staff of the Commission ("Staff") filed a Non-Unanimous Stipulation and Agreement in Commission File No. GM-2011-0412. While not unanimous, all parties to that matter are either signatories (MGE, Staff, Sigma Acquisition Corporation, and Energy Transfer Equity) or have stated that they will not object to, nor request a hearing in regard to, the Stipulation (Office of the Public Counsel).

3. The Stipulation in File No. GM-2011-0412, in part, states that "MGE shall withdraw Case No. GE-2011-0282 with prejudice upon Commission approval of this Stipulation and Agreement becoming final and non-appealable."

4. Given the potential that the GM-2011-0412 Stipulation may make further processing of this case moot, MGE, with the support of counsel for the Staff and the Office of


the Public Counsel,¹ requests that the procedural schedule events in this matter be extended by an additional 30 days² to allow the Commission to rule on the referenced Stipulation.

5. The requested extension would result in the following approximate dates for the remaining procedural events:

Surrebuttal Testimony from Missouri Gas Energy	March 27, 2012
Cross-Surrebuttal Testimony from Staff and Public Counsel	March 27, 2012
Issues List, Witness List, Order of Witnesses, Order of Opening Statements	April 5, 2012
Position Statements	April 16, 2012
Stipulation of Undisputed Material Facts	April 20, 2012
Evidentiary Hearing	May 10-11, 2012
Simultaneous Post-Hearing Briefs	June 11, 2012
Proposed Findings of Fact and Conclusions of Law	June 19, 2012

WHEREFORE, MGE respectfully requests that the Commission issue its order extending the procedural schedule in the manner described herein.
