
**NOTICE SEVERING AND CLOSING**  
**CASE NOS. MX-2000-430 and MX-2000-431**

This notice severs Case Nos. MX-2000-430 and MX-2000-431 from the previously consolidated cases identified as Case No. MX-2000-430 et al., and closes the two severed cases.

On October 5, 2000, the Commission issued its order consolidating four rulemaking cases, Case Nos. MX-2000-430, MX-2000-431, MX-2000-433 and MX-2000-445, which all proposed amendments to change the nomenclature from "mobile home" to "manufactured home". Case No. MX-2000-430 was designated as the lead case.

On September 25, 2001, the Staff of the Commission notified the Commission that the proposed amendments to Commission Rule 4 CSR 240-121.050 filed in Case No. MX-2000-430 and Commission Rule 4 CSR 240-121.060 in Case No. MX-2000-431 would be withdrawn because Senate Bill 317 (91<sup>st</sup> General Assembly, effective August 28, 2001), amended Chapter 700, removing the Commission's jurisdiction related to these two rules. Therefore, the proposed amendments will be withdrawn and a proposed rescission will be filed in a new rulemaking filing. Withdrawal of these two proposed amendments obviates the need to proceed with Case Nos. MX-2000-430 and MX-2000-431. Therefore, Case Nos. MX-2000-430 and MX-2000-431 may be severed from the consolidated cases and may now be closed. Orders of Rulemaking will be filed in Case Nos. MX-2000-433 and MX-2000-445, and therefore, Case Nos. MX-2000-433 and MX-2000-445 will continue to be consolidated and Case No. MX-2000-433 will be designated as the lead case.

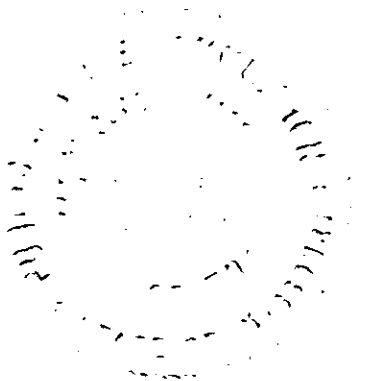
