If closing does not take place within thirty (30) days following the effective date of the Commission's order, Hillcrest is required to submit a status report within five (5) days after this thirty (30) day period regarding the status of closing, and additional status reports within five (5) days after each additional thirty (30) day period, until closing takes place, or until Hillcrest determines that a sale will not occur.

2. The Commission's Order Approving Stipulation and Agreement and Granting a

Certificate of Convenience and Necessity was issued on October 22, 2014, effective November

1, 2014.

3. Closing of this transaction has not yet taken place. Hillcrest continues to work

through closing issues related to Attorney General/Department of Natural Resources

enforcement issues, the Hillcrest Manor Subdivision Homeowners Association, and other

matters. If Hillcrest has not closed on this transaction by January 1, 2015, it will file another

status report by January 5, 2015.

WHEREFORE, Hillcrest respectfully requests that the Commission consider this Status

Report to satisfy the identified provision of the Nonunanimous Stipulation and Agreement, as

approved by the Commission.
