

**NOTICE OF WITHDRAWAL OF
MOTION FOR EXPEDITED TREATMENT**

COMES NOW Associated Natural Gas Company ("ANG"), by and through its counsel,
and for its Notice of Withdrawal of Motion for Expedited Treatment, respectfully states as
follows:

1. On July 17, 2001, ANG, the Staff of the Commission ("Staff"), the Office of the
Public Counsel ("Public Counsel"), and Atmos Energy Corporation ("Atmos"), submitted to the
Commission a "Settlement Agreement and Release" and a "Motion for Expedited Treatment."

The settlement document reflected a unanimous settlement which had been achieved between the parties to the above-captioned proceedings.

2. The Commission held a Question and Answer Session on the record in this matter on Wednesday, July 25, 2001.


3. The Parties to the Settlement Agreement and Release are working to address the questions and concerns raised by the Commission. The pending oral argument in a circuit court case which was a subject of the Settlement Agreement and Release, which had been the driving factor for Commission action prior to August 1, 2001, has now been temporarily postponed after consultation with the circuit judge.

4. The Parties therefore wish to advise the Commission that there is no longer the same urgency for Commission approval of the Settlement Agreement and Release, that the Parties are working on a revised version of the document, and that as soon as it is finalized it will be presented to the Commission. Therefore, there is no need for the Commission to take any formal action on the Settlement Agreement and Release that was submitted on July 17, 2001, and there is no need for the Motion for Expedited Treatment.

5. Counsel for the Commission, Public Counsel, Atmos and the Staff have reviewed and consented to the filing of this notice. There are no other parties involved in the referenced cases.

WHEREFORE, ANG, for itself and on behalf of Public Counsel, the Staff, and Atmos, hereby withdraws the previously filed Motion for Expedited Treatment.


