#### NOTICE SETTING HEARING ON STIPULATION AND AGREEMENT

On September 20, 2000, all of the parties filed a unanimous stipulation and agreement (agreement) with the Missouri Public Service Commission (Commission).

The Commission will convene a hearing on Wednesday, October 4, 2000, at 10:00 a.m. in Suite 310 (the main hearing room) in the offices of the Missouri Public Service Commission in Jefferson City, Missouri, located on the main floor of the Governor Office Building, 200 Madison Street. The Governor Office Building meets the accessibility standards required by the Americans with Disabilities Act. The agreement stated, inter alia, that

[t]he Staff [of the Commission] shall submit to the Commission a memorandum explaining its rationale for entering into this Unanimous Stipulation and Agreement. Each of the Parties shall be served with a copy of such memorandum and shall be entitled to submit to the Commission a responsive memorandum, which shall also be served on all Parties.



Thus, the Commission will require that the Staff file its memorandum no later than September 27, 2000, and that any party wishing to respond shall file its response no later than October 2, 2000.

In addition, the parties are notified that if any party wishes to request an expedited transcript, that such should be requested from the court reporter no later than October 4, 2000.
