RE: Damage Claim 5/1/98

Dear Mr. Biersmith:

In response to your earlier request I have independently reviewed the account information, electrical operations as well as the investigation of your damage claim by Morrow Management Services. We have found no evidence of any interruption of power or voltage irregularity for the date you have indicated you experienced difficulty with you telephone system.

After obtaining this information I did speak with Mr. Pack. He does confirm that he previously denied your claim due to lack of any objective evidence that you experienced an irregularity which can be attributed to the KCPL distribution system. I also examined other customers' accounts who are served on the same circuit that supplies power to Industrial Medical Centers, Inc. and have concluded there was no evidence to support a "surge on the electrical power grid", as you suggested. KCPL can only pay claims based on negligence with an assessment of legal liabilities and for that reason I must, respectfully, deny your property damage claim.

In looking at your usage records I found that both of your electric accounts are seriously in arrears and subject to termination of electric service for non-payment.
