# APPLICATION FOR APPROVAL OF PAGING INTERCONNECTION AGREEMENT

COMES NOW Applicant Arch Wireless Operating Company, Inc. ("Applicant" or "Arch Wireless"), by and through counsel and pursuant to Sections 251 and 252 of the Federal Telecommunications Act of 1996 ("the Federal Act") and the applicable provisions of 4 CSR 240-2.060, and for its Application For Approval of Paging Interconnection Agreement ("the Agreement") with Southwestern Bell Telephone L.P. d/b/a Southwestern Bell Telephone Company ("SWBT"), respectfully states as follows:

1. Pursuant to 4 CSR 240.2.060(1)(A), Applicant's legal name is Arch Wireless
Operating Company, Inc. Applicant's principal office is located at 1800 West Park Drive,
Suite 250, Westborough, Maryland 01581-3912, telephone number (508) 870-6005, fax
number (508) 870-8005, 4482724@archwireless.net (email address). Applicant is authorized
to do business in Missouri as a foreign corporation, and pursuant to 4 CSR 240-2.060(1)(C),
relevant documents from the Missouri Secretary of State's Office are attached hereto as

Appendix A. Pursuant to 4 CSR 240-2.060(1)(H), Applicant is a Delaware corporation
engaged in the provision of interstate commercial mobile radio services under authority granted

by the Federal Communications Commission.

2. Pursuant to 4 CSR 240-2.060(1)(I), all correspondence, communications, orders and decisions regarding this Application should be sent to:

- 3. Pursuant to the relevant provisions of Section 386.020 RSMo 2000, Applicant is not a "public utility" and therefore is not subject to the general regulatory jurisdiction of the Commission. However, the Commission does have jurisdiction over both the subject Interconnection Agreement pursuant to the Federal Act, and over the co-signatory to the Interconnection Agreement, incumbent local exchange telecommunications company SWBT, pursuant to Chapters 386 and 392 RSMo 2000. Pursuant to 4 CSR 240-2.060(1)(K), Applicant states that it has no pending action or final unsatisfied judgments or decisions against it from any state or federal agency or court which involve customer service or rates, which action, judgment or decision has occurred within three (3) years of the date of this Application. 4 CSR 240-2.060(1)(L), regarding Commission annual reports and assessments, does not apply to Applicant as Applicant is not subject to the Commission's general regulatory jurisdiction. Pursuant to 4 CSR 240-2.060(1)(M), the notarized verification of David M. Wilson, counsel for Applicant, is attached hereto.
- 4. Consistent with its standard practice, co-signatory SWBT is not a joint applicant for purposes of this proceeding. However, Applicant anticipates that the Commission will

automatically make SWBT a party to this case as the Commission has done in the past in similar cases of this type.

- 5. Applicant presents to the Commission for its approval the Paging Interconnection Agreement, with appendices, negotiated and finally executed by and between Applicant and SWBT on January 15, 2003 pursuant to the terms of the Federal Act. An executed original of the Agreement with appendices, with the pages numbered sequentially in the bottom right hand corner, has been filed this date along with this Application.
- 6. Applicant seeks Commission approval of the Agreement, consistent with the provisions of the Federal Act. Applicant believes that the implementation of the Agreement fully complies with Section 252(e) of the Federal Act because the Agreement is consistent with the public interest, convenience and necessity and because it does not discriminate against any telecommunications carrier. The Agreement promotes diversity in providers, promotes interconnectivity, and increases customer choices for telecommunications services in Missouri. As such, the Agreement also is consistent with the policies of Chapter 392 RSMo.
- 7. The Agreement is a multi-state agreement and is in all substantive respects similar to other wireless interconnection agreements which have been previously approved or which are currently under review by the Commission. There are no outstanding issues between the parties which require arbitration by the Commission. In order to avoid additional post-approval filings, Applicant already has sequentially numbered the pages of the Agreement in the bottom right hand corner of each page consistent with the Commission's past practice. As such, Applicant requests prompt approval of the Agreement without change, suspension or other delay in implementation.

8. The appropriate standards of review of the Agreement by the Commission are found in Section 252(e) of the Federal Act and are well-known to the Commission. Applicant respectfully submits that under these standards, this Commission should not reject and should approve the Agreement, consistent with the Commission's past treatment in prior cases involving similar SWBT wireless interconnection agreements.

WHEREFORE, Applicant Arch Wireless Operating Company, Inc. respectfully requests that the Commission approve its Paging Interconnection Agreement with Southwestern Bell Telephone, L.P. d/b/a Southwestern Bell Telephone Company.


