Comes Now Sprint Communications Company, L.P. (“Sprint”), pursuant to 4 CSR 240-2.065(2) and 4 CSR 240-2.080(16) and requests expedited approval on or before July 1, 2006 of the attached tariff changes to implement the contractual terms agreed to by Sprint and the Missouri Public Service Commission for the provision of Telephone Relay Service (“TRS Service”) in Missouri. In support of its Motion for Expedited Treatment states as follows:

1. Sprint has been providing TRS service in the state of Missouri pursuant to a contract set to expire on June 30, 2006. On June 8, 2006, Sprint received notice from the Commission that the contract has been extended effective July 1, 2006.

2. Sprint has been interpreting the contract and developing the attached tariff pages necessary to implement the contract. See attached cover letter and tariff sheets. This motion is being filed as soon as Sprint reasonably could make the necessary tariff adjustments. Moreover, expedited treatment is necessary since the contract award was made less than thirty days before the effective date of the contract.

4. Expedited approval of the attached tariff filing will serve the public interest and the will of the Commission's award of the contract to Sprint effective July 1, 2006.

WHEREFORE, for the foregoing reasons, Sprint seeks expedited approval of its attached tariff so the tariff is effective on July 1, 2006.



.25 School and Library Discounts (continued)

.4 Failure to Obtain Support

- .1 The Customer will reimburse Sprint if the FCC, SLD or Funding Sources fail to do so or if the FCC, SLD or Funding Sources reclaim any portion of Support sent to Sprint on Customer's behalf. Customer will not be responsible for Support withdrawn due to Sprint's material failure to provide Service.
- .2 Sprint is not responsible for the Customer's compliance with FCC, SLD or Funding Source rules and regulations, the Customer's applications for Support, or any decisions or actions by the FCC, SLD or Funding Sources with respect to the Customer.
- .3 For Service agreements of more than one year, the Customer may not terminate the Agreement based solely on its failure to receive Support.

.26 Telecommunications Relay Service

Intrastate toll calls received from the relay service shall receive the following discount.

- .1 Residential Sprint Relay users will be given a 50% discount off of the Sprint Service per-minute usage rates.
- .2 Business Sprint Relay users will be given a 50% discount off of the Business Sense per-minute usage rates.
- .3. If a Sprint subscriber is on a special promotion plan, the caller is charged at his/her special promotion rate, not the Relay Missouri rate.
- .4 These discounts commence on July 1, 2006 and will continue for a period of two (2) years, unless earlier terminated or modified in accordance with this Tariff. These discounts may be extended for two (2) additional years.
