## **STATUS REPORT**

COMES NOW the Staff of the Missouri Public Service Commission (Staff) and for its report on the status of this case states:

- 1. On April 27, 2000, OnSite Access Local, LLC (OnSite) filed its application for a certificate of authority to provide basic local service together with a motion for a protective order. The Public Service Commission (Commission) granted the motion by issuing a protective order with an effective date of May 19, 2000.
- 2. Southwestern Bell Telephone Company (SWBT) applied to intervene on May 31, 2000 and by order effective June 16, 2000, the Commission granted SWBT intervention. The Commission also ordered the parties to file a proposed procedural schedule. On June 28, 2000, the Commission adopted the procedural schedule filed by Onsite on June 22, 2000.
- 3. In response to OnStite's motion to suspend procedural schedule filed on October 16, 2000, the Commission, by order effective October 29, 2000,

- suspended the procedural schedule and ordered the parties to file a stipulation and agreement or proposed procedural schedule by January 29, 2001.
- 4. On November 7, 2000, at the Staff's request, OnSite submitted under seal a supplement to Exhibit 3 of its application.
- 5. By order dated November 15, 2000, the Commission directed the parties to file by November 27, 2000, a report on the progress of the case. This filing is made in response to that order.
- 6. With the November 7, 2000 supplement to the application, the Staff is ready to execute a stipulation and agreement containing acceptable provisions. The parties remain in the process of negotiating agreement as to all of the terms to that stipulation and agreement. A revised draft stipulation and agreement is presently circulating and Onsite has advised the Staff that it anticipates the final agreement will be ready for filing within a week or two.

WHEREFORE, the Staff advises the Commission that negotiation of a stipulation and agreement is progressing in this case, and that the Staff anticipates resolution of this case by settlement.
