## PROPOSED PROCEDURAL SCHEDULE OF STAFF

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), and for its Proposed Procedural Schedule, respectfully states to the Commission as follows:

- 1. On April 28, 2000, OnFiber Carrier Services, Inc. ("OnFiber") filed an application for authority to provide and/or resell basic local, local exchange and interexchange telecommunications services.
- 2. On June 19, 2000, the Commission issued its Order directing the parties to file a proposed procedural schedule no later than July 10, 2000.
- 3. On July 10, 2000, OnFiber filed a Motion for Extension of Time to File Stipulation and Agreement.
- 4. The Commission granted OnFiber's Motion for Extension and extended the Stipulation and Agreement due date to August 10, 2000.
- 5. On August 10, 2000, OnFiber filed a Motion for Second Extension of Time to File Stipulation and Agreement.
- 6. The Commission granted the request and extended the deadline to file the Stipulation and Agreement to September 10, 2000.



- 7. On September 7, 2000, OnFiber filed a third Motion for Extension of Time to File Stipulation and Agreement
- 8. The Commission granted this Third Motion for Extension of Time to file Stipulation and Agreement and extended the deadline to September 29, 2000.
- Staff has not yet received a final Stipulation and Agreement from the other parties.
   Accordingly, Staff proposes the Procedural Schedule discussed herein.

Surrebuttal by All Parties	December 8, 2000
Prehearing Conference	December 15, 2000
Statement of Issues including the Order of Witnesses and Order of Cross-Examination	December 29, 2000
Statement of Positions	January 10, 2001
Hearing	January 22, 2001

- 10. A proposed Stipulation and Agreement has been distributed between the Parties and most of the Issues have been resolved between the parties. Staff fully expects that all of the Parties will continue to work diligently to complete and file a Stipulation and Agreement prior to the due date of OnFiber's Direct Testimony. However, since a Stipulation and Agreement has not yet been filed, the Staff proposes this Procedural Schedule.
- 11. Southwestern Bell Telephone Co. and Office of Public Counsel have no objection to this Procedural Schedule.

WHEREFORE, the Staff respectfully requests that the Commission approve the Proposed Procedural Schedule.
