**SOUTHWESTERN BELL TELEPHONE COMPANY'S  
APPLICATION TO INTERVENE**

COMES NOW Southwestern Bell Telephone Company (SWBT) and respectfully  
submits its Application to Intervene in this proceeding pursuant to 4 CSR 240-2.060 and 2.075.

In support of its Application, SWBT states:

1. SWBT is a Missouri corporation duly authorized to conduct business in Missouri with its principal Missouri office at One Bell Center, St. Louis, Missouri 63101. SWBT is a "local exchange telecommunications company" and a "public utility" and is authorized to provide "telecommunications service" within the state of Missouri as each of those phrases are defined in §386.020 RSMo (1994).

3. In this proceeding, Digital Access Corporation of Missouri, Inc. (Digital Access) seeks a certificate of service authority to provide basic local service, nonswitched local exchange service and interexchange telecommunications services in exchanges currently served by GTE Midwest, Incorporated, Sprint Missouri, Inc. and SWBT. Digital Access seeks classification as a

competitive company and to receive a lesser degree of regulation as permitted under Sections 392.361 and 392.420 RSMo. (1994) and the waiver of various statutory provisions and Commission rules.

4. Pursuant to the requirements set forth in 4 CSR 240-2.075(2), SWBT states as follows. The services which Digital Access seeks Commission authority to provide will be offered in direct competition with SWBT if Digital Access' Application in this proceeding is granted. SWBT therefore has a direct interest in the Commission's decision on Digital Access' Application. At this point, SWBT does not have sufficient information to either support or oppose Digital Access' Application.

5. This Commission should permit intervention pursuant to 4 CSR 240-2.075(4)(A) because SWBT's interests as a provider of basic local exchange service differ from those of the general public. No other party to this proceeding will adequately protect SWBT's interest.


6. This Commission should also permit intervention pursuant to 4 CSR 240-2.075(4)(C) because granting SWBT's Application to Intervene is in the public interest in that SWBT will bring to this proceeding its extensive expertise and experience as a telecommunications provider.

WHEREFORE, SWBT respectfully requests the Commission to grant this Application to Intervene.


