**ORDER APPROVING TARIFF**

On October 26, 2000, the Commission issued an order amending the certificate of authority to provide basic local telecommunications previously issued to Snappy Phone of Texas, Inc., d/b/a Snappy Phone (Snappy Phone), in Case No. TA-2000-272. The amendment expanded Snappy Phone's service area to include authority in exchanges served by GTE Midwest, Inc. (now d/b/a Verizon Midwest) and Sprint Missouri, Inc. The expanded service authority was conditioned upon Snappy Phone filing appropriate tariff sheets by December 4, 2000.

As Snappy Phone did not file the required tariff sheets by December 4, 2000, the Commission issued an order on January 4, 2001, directing Snappy Phone to file a status report informing the Commission of when it intended to file the compliant tariff sheets.

Snappy Phone filed a letter on February 6, 2001, advising the Commission that it intended to file tariff sheets on March 1, 2001. Snappy Phone filed the proposed tariff sheets on February 22, 2001, but then withdrew them by letter filed March 2, 2001.

On June 12, 2001, the Commission issued a Second Order Directing Filing instructing Snappy Phone to file, by June 26, 2001, either proposed tariff sheets or an

appropriate pleading updating the Commission as to the status of the case. On June 14, 2001, Snappy Phone filed the proposed tariff sheets with an effective date of July 30, 2001.

The Commission's Staff reviewed the proposed tariff sheets and filed a recommendation on June 22, 2001. Staff indicates that the tariff sheets comply with the Commission's Order Amending Certificate of Authority to Provide Basic Local Telecommunications Services issued October 26, 2000. Staff recommends that the Commission approve Snappy Phone's proposed tariff to become effective July 30, 2001.

The Commission has reviewed the tariff sheets and Staff's recommendation and finds that the tariff sheets conform to the Commission's order of October 26, 2000, and should be approved to become effective on July 30, 2001. The amendment to the company's service authority shall become effective on July 30, 2001.

**IT IS THEREFORE ORDERED:**

1. That the tariff filed by Snappy Phone of Texas, Inc., d/b/a Snappy Phone, on June 12, 2001, tariff file number 200101185, is approved to become effective on July 30, 2001. The approved tariff is:

2. That this order shall become effective on July 30, 2001.
