**HOLWAY LONG DISTANCE COMPANY'S
RESPONSE TO NOTICE REQUIRING FILING**

Comes now Holway Long Distance Company ("Holway") and for its Response to Notice Requiring Filing states to the Missouri Public Service Commission ("Commission") as follows:

1. On May 26, 2000, Holway and Fiber Four Corporation ("Fiber Four") filed a Joint Application with the Commission requesting a certificate of service authority to provide interexchange telecommunications services for Holway and requesting authority to transfer certain assets of Fiber Four now used in the provision of long distance service for Fiber Four d/b/a Holway Long Distance.

2. On June 28, 2000, the Commission issued its Notice Requiring Filing in which it directed Holway to file a copy of its registration of fictitious name filed with the Missouri Secretary of State. The Commission stated that Holway indicated that it would provide services under the name "Holway Long Distance." As a matter of clarification, Holway does not seek a certificate using a fictitious name, but rather seeks a certificate in its corporate and legal name - Holway Long Distance Company.

Wherefore, Holway Long Distance Company respectfully requests that the Commission accept its clarification that the authority is sought for Holway Long Distance Company and not Holway Long Distance Company d/b/a Holway Long Distance.
