Comes now Holway Long Distance Company ("Holway") and for its Response to Notice Requiring Filing states to the Missouri Public Service Commission ("Commission") as follows:

- 1. On May 26, 2000, Holway and Fiber Four Corporation ("Fiber Four") filed a Joint Application with the Commission requesting a certificate of service authority to provide interexchange telecommunications services for Holway and requesting authority to transfer certain assets of Fiber Four now used in the provision of long distance service for Fiber Four d/b/a Holway Long Distance.
- 2. On June 28, 2000, the Commission issued its Notice Requiring Filing in which it directed Holway to file a copy of its registration of fictitious name filed with the Missouri Secretary of State.
