**ORDER GRANTING SECOND EXTENSION**  
**OF TIME TO FILE STIPULATION AND AGREEMENT**

On April 28, 2000, OnFiber Carrier Services, Inc. (OnFiber), filed an application for authority to provide and/or resell basic local, local exchange and interexchange telecommunications services. The Public Service Commission (Commission) granted OnFiber's Motion to Adopt Protective Order on May 23, 2000. On June 8, 2000, the Commission entered a Notice of Deficiency and Order Directing Filing, ordering OnFiber to file a pleading setting forth a specific reference to the statutory authority under which OnFiber requested relief, pursuant to 4 CSR 240-2.080(3), by June 19, 2000.

Pursuant to the Commission's Order, OnFiber submitted a Motion to Amend by Interlineation the First Page of the Application. Furthermore, OnFiber filed a Motion for Extension of Time to File Stipulation and Agreement on July 10, 2000. On July 28, 2000, the Commission granted OnFiber's Motion for Extension and extended the Stipulation and Agreement due date to August 10, 2000.

On August 10, 2000, OnFiber filed a Motion for Second Extension of Time to File Stipulation and Agreement. In its Motion, OnFiber asserts

that the Stipulation and Agreement was due on August 10, 2000, and, although the Stipulation has been distributed to the parties in draft form, OnFiber requires additional time. OnFiber requests the Commission allow it until September 11, 2000, to file the Stipulation and Agreement.

The Commission has reviewed the August 10, 2000, motion for an extension until September 11, 2000, to file the Stipulation and Agreement and finds that it is reasonable under the circumstances, and should be granted.

**IT IS THEREFORE ORDERED:**

1. That the Second Motion for Extension of Time to File Stipulation and Agreement is granted and that OnFiber Carrier Services, Inc., shall have until September 11, 2000, to file the Stipulation and Agreement.

2. That this order shall become effective on August 25, 2000.
