CORRECTION TO REVENUE REQUIREMENT

COMES NOW the Staff of the Missouri Public Service Commission (Staff), Missouri Gas Energy (MGE), and the Office of the Public Counsel (OPC), and for this correction states:

- 1. Pursuant to the Stipulation and Agreement filed with the Commission on May 20, 1998, the parties agreed to gross-up the revenue deficiency related to uncollectibles expense and gross-down the revenue deficiency related to late payment charge revenues. (Page 3, Item S).
- 2. It has recently been discovered that this gross-up/gross-down of uncollectibles and late payment charge revenues was not included in the scenario filed with the Commission.
- 3. The agreed-upon revenue requirement number of \$13,297,499 needs to be grossed-up for uncollectible expense and grossed-down for late payment revenues. Proper accounting for this gross-up/gross-down produces an overall revenue requirement of \$13,404,463. The Staff, MGE and OPC all agree that the revenue requirement should be increased to this amount to reflect the item from the Stipulation and Agreement that was inadvertently omitted from the revenue requirement.

WHEREFORE, the Staff, MGE and OPC request the Commission correct the revenue requirement ordered in this case to include the gross-up/gross-down of uncollectibles and late payment charge revenues and which results in an overall revenue requirement of \$13,404,463.
