NOTICE AND CERTIFICATION OF TARIFF FILING

Comes now Adelphia Business Solutions Operations, Inc. ("Adelphia"), pursuant to the Commission's *Order Granting Certificate to Provide Basic Local Telecommunications Services* issued in the above-captioned case on November 18, 1999, and for its Notice And Certification Of Tariff Filing, respectfully states as follows:

I. Procedural History

1. On November 18, 1999 the Commission in Case No. TA-2000-215 issued its Order granting Adelphia a conditional certificate of service authority to provide basic local telecommunications services in portions of the State of Missouri. In said Order, the Commission ordered Adelphia, *inter alia*, to file in Case No. TA-2000-215 proposed tariff sheets bearing a forty-five day effective date within 30 days after the effective date of a Commission order approving Adelphia's interconnection agreement with an incumbent local exchange telecommunications company.

2. On January 20, 2000 Adelphia filed an application with the Commission for approval of Adelphia's interconnection agreement with Southwestern Bell Telephone Company ("SWBT"). That case was docketed as Case No. TO-2000-454 and is still pending before the Commission.

II. Certification, Notice and Disclosure

3. Adelphia hereby notifies all parties to Case No. TA-2000-215 that it has this day filed with the Commission Adelphia's proposed basic local tariff and exchange access tariff, each bearing a forty-five day effective date, and has sent a copy of same, along with this pleading, to counsel for all parties of record in Case No. TA-2000-215. **Any questions regarding these proposed tariffs should be directed to Karen Hyde at 412-220-5704 or to Jim Stinson 412-220-5079 at Adelphia.**


4. Adelphia further states and discloses that it has filed for Commission approval Adelphia's interconnection agreement with SWBT in Case No. TO-2000-454 and that case is still pending before the Commission. Adelphia has not yet executed nor received Commission approval of any interconnection agreements with any other incumbent local exchange telecommunications companies although Adelphia's certificate also includes those exchanges served by GTE Midwest Incorporated and Sprint Missouri, Inc. Adelphia anticipates executing interconnection agreements with these other incumbent providers and filing same for Commission approval at some time in the future.

5. As Adelphia's proposed tariffs only govern service to be provided by Adelphia in SWBT exchanges, no interconnection or resale agreement with other incumbent local exchange companies is required at this time. Once Adelphia executes and receives approval of interconnection agreements with these other incumbent local exchange companies, Adelphia will file the necessary tariffs governing the provision of service in exchanges served by GTE Midwest Incorporated and Sprint Missouri, Inc. accordingly.

WHEREFORE, Adelphia Business Solutions Operations, Inc. notifies all parties that it

has this date filed its proposed basic local exchange and exchange access telecommunications tariffs governing service in a portion of Adelphia's certificated service area, that it has sent a copy of said tariffs and this pleading to counsel for all parties of record in Case No. TA-2000-215, and otherwise certifies compliance regarding disclosure of all Adelphia's interconnection agreements pursuant to the Commission's Order issued on November 18, 1999 in this case.
