ADDITIONAL ORDER OF MODIFICATION

On January 30, 1998, the Commission issued its Order of Correction and Modification in this case. On February 2, 1998, Missouri-American Water Company (MAWC) filed a Motion for Additional Correction and Modification. In that motion, MAWC states that it wishes to bring to the Commission's attention that one modification may have been made in error.

MAWC states that a change was made in the Correction Order to ordered paragraph No. 1 of the original Report and Order. MAWC states that the effect of the change in the ordered paragraph is to deny MAWC a certificate for area number one. MAWC does not think this is the Commission's intent. MAWC is of the opinion that the Commission intended

to make the correction to the preceding paragraph, which would be consistent with the remainder of the corrections and modifications.

No other responses were made by the remainder of the parties to this case.

The Commission finds that MAWC is correct in its assertion that the specified change was made to the wrong paragraph. The Commission will correct ordered paragraph No. 1 by returning it to its original form as found in the Report and Order. Ordered paragraph No. 1 will now read:

"1. That the application of Missouri-American Water Company for certificates of convenience and necessity to construct, install, own, operate, control and manage water supply and distribution systems in Areas 1 and 2, as set out in this Report and Order and Attachment A to this Report and Order, is hereby granted."

In a like fashion, the Commission will correct numbered paragraph 3 on page 17 of the original Report and Order to read:

"That Missouri-American Water Company is found to have operated outside its service in Areas 2 and 3, as set out this Report and Order, in violation of Sections 393.170 and 386.570, RSMo. 1996."

In addition, the Commission notes a typographical error in the Order of Correction and Modification, issued January 30, 1998. In ordered paragraph No. 4, the effective date is corrected to read "1998," not "1997."

IT IS THEREFORE ORDERED:

1. That the Missouri-American Water Company Motion for Additional Correction and Modification is granted as set out above.

2. That the above additional corrections are hereby ordered.

3. That this order shall become effective on March 17, 1998.
