## NOTICE OF APPLICATIONS AND RIGHT TO INTERVENE AND ORDER TO FILE TARIFF

Section 392.361, RSMo Supp. 1993 requires the Missouri Public Service Commission to give all interested persons reasonable notice and an opportunity to be heard to determine whether a telecommunications company should be classified as a competitive company and subjected to a lesser degree of regulation. Accordingly, YOU ARE HEREBY NOTIFIED that the entities listed in the schedule accompanying this notice have applied to the Missouri Public Service Commission for certificates of service authority and classification as competitive telecommunications services providers.

The Commission must approve a certificate of service authority for the resale of interexchange telecommunication services or for the resale of local exchange services upon a showing by the Applicant, and a finding by the Commission, that the grant of authority is in the public interest. Section 392.440, RSMo Supp. 1993. The Commission may classify a company as competitive only if it finds that all telecommunications services offered by that company are competitive telecommunications services. Section 392.361.3, RSMo Supp. 1993. Certificates of service authority and competitive classification will be granted to these applicants, upon favorable recommendation by Commission staff, without hearing unless a

proper party intervenes and requests a hearing. A proper party is any party who desires to contest whether certification of the Applicant is in the public interest.

If you wish to intervene you may do so by filing a written application to intervene on or before 3:00 p.m. on the date specified for intervention on the Schedule of Applicants attached to this notice. Motions to intervene should be addressed to the Executive Secretary of the Missouri Public Service Commission, Post Office Box 360, Jefferson City, Missouri 65102, and copies served on the applicant, the applicant's attorney, and all known intervenors. Objections to a motion to intervene must be filed in writing with the Missouri Public Service Commission by 3:00 p.m. on the tenth day after the filing of the motion to intervene. Persons objecting to a motion to intervene must state the reasons for their objection.

Any person desiring a copy of the application filed in any of the cases listed below may receive one upon written request to the Executive Secretary of the Missouri Public Service Commission, Post Office Box 360, Jefferson City, Missouri 65102.

Each applicant listed on the accompanying Schedule of Applicants shall file with the Commission a proposed tariff carrying a 30-day effective date. The tariff must be filed no more than ten days after the intervention date indicated on the Schedule of Applicants but must not be filed before the intervention date. The proposed tariff should reflect the rates, rules, and regulations the company intends to use for providing services in Missouri.
