APPLICATION TO INTERVENE OF INTERNATIONAL BROTHERHOOD OF ELECTRICAL WORKERS, LOCAL UNION NO. 1439

COMES NOW the International Brotherhood of Electrical Workers, Local Union No. 1439 ("IBEW Local 1439"), affiliated with A.F.L.-C.I.O., pursuant to 4 CSR 240-2.075 and the Commission's Order and Notice ("Order") issued herein on November 8, 1999, and in support of its Application to Intervene respectfully states as follows:

- In the Order, the Commission stated that interested parties would have 1. until "on or before November 29, 1999" to file applications to intervene. This Application to Intervene is therefore being timely filed.
- 2. IBEW Local 1439 is a labor organization as defined in the National Labor Relations Act, as amended. IBEW Local 1439 represents the outside physical employees of Associated Natural Gas Company ("ANG"), one of the Joint Applicants in this case, as certified by the National Labor Relations Board. The members of IBEW Local 1439

which are covered by the current Labor Agreement with ANG are based in several locations throughout Missouri and northeastern Arkansas.

- 3. The ANG employees represented by IBEW Local 1439 may be affected by orders entered by the Commission in this proceeding and, accordingly, IBEW Local 1439 and the employees it represents are interested in this proceeding.
- 4. Because IBEW Local 1439 and the employees it represents may be directly affected by the Commission's decisions and orders in this case, IBEW Local 1439 and the employees it represents have a direct interest in this proceeding which is different from that of the general public, and which cannot be adequately represented by any other party. Furthermore, granting the intervention of IBEW Local 1439 will serve the public interest because it will ensure that the rights of the employees represented by IBEW Local 1439 are protected.
- 5. While IBEW Local 1439 does not currently have sufficient information to support or oppose the Joint Application which initiated this proceeding, IBEW Local 1439 is concerned that decisions or orders of the Commission herein could adversely affect the work opportunities, employment security and various terms and conditions of employment of the ANG employees represented by IBEW Local 1439, and is also concerned with the potential detriment to customers in the event that the Joint Application is approved and Atmos Energy Corporation reduces its workforce or combines locations. IBEW Local 1439 does not currently have sufficient information to support or oppose the Joint Application in part because to date, after several requests from IBEW Local 1439, IBEW Local 1439 has not had the opportunity to meet with

representatives of the Joint Applicants in order to better understand the intent of management when, or if, the sale which is the subject of this proceeding is approved.

- 6. IBEW Local 1439 submits that it meets the criteria for intervention set forth in 4 CSR 240-2.075 and, accordingly, that its Application to Intervene should be granted. IBEW Local 1439 would also note that the Commission has previously granted intervention to local unions in Commission cases on grounds substantially similar to those set forth herein.
