COMES NOW Atchison County, Missouri by and through the County Commission composed of Presiding Commissioner Curtis Livengood, and North District Associate Commissioner James Quimby, and South District Associate Commissioner Richard Burke (collectively referred to hereafter as “Atchison County”), by and through its counsel Ivan L. Schraeder, of counsel to The Wagner Law Group, and pursuant to 4 CSR 240-2.075, applies to intervene in the above case. For its Application, Atchison County states:

1. Atchison County, Missouri is a political subdivision created under the laws of Missouri as a third class county with its principal place of business located at 400 S. Washington Street, Rock Port, MO 64482.
2. Atchison County, Missouri is represented by counsel identified below in this pleading.
3. Atchison County, Missouri is interested in this litigation because any decision issued in this matter may serve to reduce general revenue payable to the County from taxes that are now payable for the subject properties that may be lost by virtue of changes requested by Petitioner, such reduction in tax revenues will have a permanent and direct adverse impact on County operations and the services provided to the citizens of Atchison County, Missouri.

4. Atchison County, Missouri opposes the relief sought by the Petitioner as it is currently requested.
