SUPPLEMENTAL ORDER CANCELING CERTIFICATE AND TARIFFS

On September 17, 1993, the Commission issued its Report And Order herein effective October 1, 1993, that authorised Sho-Me Power Corporation (Sho-Me) to convert from a Chapter 393, R.S.Mo. 1986, regulated electric company to a Chapter 394, R.S.Mo. 1986, rural electric cooperative. The Commission further ordered Sho-Me to pay its delinquent annual assessments. On September 21, 1993, Sho-Me filed its Compliance With Commission Order along with two checks in the sum of \$102,438.08 which represented payment of the annual assessment for the fiscal year beginning July 1, 1992, and \$30,878.87 which represented payment of the annual assessment as prorated for the fiscal year beginning July 1, 1993.

The Commission determines that since Sho-Me has fully complied with all conditions required of it by the Commission, and since Sho-Me has previously filed its Articles of Conversion with the Missouri Office of Secretary of State as specified in Section 394.070, R.S.Mo. 1986, that it would be appropriate to cancel Sho-Me's certificate and all its tariffs as of the effective date of the Report And Order and close the docket on the effective date.

IT IS THEREFORE ORDERED:

 That the certificate issued to Sho-Me Power Corporation to operate as a regulated electric company operating pursuant to Chapter 393, R.S.Mo. 1986, be hereby canceled on October 1, 1993, the effective date of the Report And Order issued herein.

- 2. That all the tariffs through which Sho-Me Power Corporation operates as a regulated electric company operating pursuant to Chapter 393, R.S.Mo. 1986, be hereby canceled on October 1, 1993, the effective date of the Report And Order issued herein.
- 3. That this docket shall be closed on October 1, 1993, the effective date of the Report And Order issued herein.
- 4. That this Supplemental Order shall become effective on the 1st day of October, 1993.
