

**ORDER DIRECTING FILING**

On October 26, 2000, the Commission issued an Order Amending Certificate of Authority to Provide Basic Local Telecommunications Services. Ordered paragraph three directed the applicant, Snappy Phone of Texas, Inc., d/b/a Snappy Phone (Snappy Phone), to file an appropriate proposed tariff no later than December 4, 2000. The Commission will direct Snappy Phone to file a status report informing the Commission of when it intends to file the proposed tariff.

**IT IS THEREFORE ORDERED:**

1. That Snappy Phone of Texas, Inc., d/b/a Snappy Phone, shall file a status report no later than February 5, 2001, informing the Commission of when it intends to file its proposed tariff.

2. That this order shall become effective on January 14, 2001.

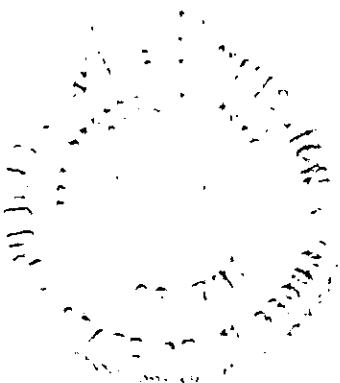
