STATUS UPDATE

COMES NOW the Staff (Staff) of the Missouri Public Service Commission (Commission) and for its status update in this matter respectfully states:

- 1. On March 9, 2000, the Staff filed a motion recommending that the Commission cancel Itelecom's certificate of service authority to provide intrastate interexchange telecommunications services, granted on January 6, 1995 in Case No. TA-95-36, and accompanying tariff. Staff gave notice of its motion via United States Mail to Mr. Adam Feinberg, President of Itelecom, and to Itelecom's attorneys who filed the application.
- 2. On May 26, 2000, the Commission issued an order directing Staff to give notice of its motion to cancel Itelecom's certificate of service authority and tariff via certified United States Mail, return receipt requested.
- 3. In accordance with the Commission's order, Staff gave notice, via certified United States Mail return receipt requested, to Mr. Feinberg and to Itelecom's attorneys of Staff's motion recommending the Commission cancel Itelecom's certificate of service authority and tariff.
- 4. Staff did not receive responses from the United States Postal Service (USPS) on this mailing for quite some time. Due to this delay, Staff resent notice, via certified United States Mail return receipt requested, to both Mr. Feinberg and to Itelecom's attorneys.

Subsequently, the USPS returned the receipt showing delivery of the original certified letter addressed to Itelecom's attorneys.

- 5. On August 11, 2000, Staff filed with the Commission a Status Update indicating that it would notify the Commission as soon as it receives a response concerning either certified letter addressed to Mr. Feinberg.
- 6. On August 30, 2000, the USPS returned the receipt showing delivery of the certified letter addressed to Mr. Feinberg.
