ORDER DIRECTING FILING

On March 27, 2000, the Staff of the Missouri Public Service Commission (Staff) filed a motion asking the Commission to cancel the certificate of authority and accompanying tariff of Touchtone Network, Inc. (TNI). TNI was originally granted a certificate of service authority by the Commission to provide intrastate interexchange telecommunications services on January 3, 1995, in Case Number TA-95-123.

On May 31, 2000, the Commission issued an Order Directing Filing which directed Staff to give notice of its Motion to Cancel Certificate of Service Authority and Accompanying Tariff by mailing a copy thereof to TNI by certified United States Mail, return receipt requested. That Order further directed Staff to file a pleading in this case advising the Commission whether the same was delivered or was returned. Staff has not yet filed such a pleading.

Therefore, the Commission will direct Staff to file, within ten days from the effective date of this order, a pleading advising the Commission as to the status of its compliance with the Commission's Order of May 31, 2000.

IT IS THEREFORE ORDERED:

- 1. That the Staff of the Missouri Public Service Commission shall file, within ten days from the effective date of this order, a pleading advising the Commission as to the status of its compliance with the Commission's Order of May 31, 2000.
 - 2. That this order shall become effective on August 2, 2000.
