ORDER CANCELING PRIVATE PAYPHONE CERTIFICATE

Coleman F. Norris (Applicant) submitted a letter to the Missouri Public Service Commission on June 23, 2000, asking the Commission to cancel Linco Communications' (Linco) payphone certificate. Applicant stated that Linco was granted a certificate in Case No. TA-95-237. The certificate was granted on April 19, 1995. Applicant stated that Linco no longer provides private pay telephone service as Linda D. Norris is deceased and the business has been sold. No objections have been filed.

Section 392.410, RSMo. (Cum. Supp. 1999), gives the Commission authority over the granting of certificates of service authority to provide telecommunications services. The Commission has reviewed the Applicant's letter and finds that the private payphone certificate granted to the Linco in Case No. TA-95-237 shall be canceled.

IT IS THEREFORE ORDERED:

1. That the private payphone certificate granted to Linco Communications in Case No. TA-95-237 is canceled.

2. That this order shall become effective on October 16, 2000.
3. That this case may be closed on October 17, 2000.
