ORDER GRANTING MOTION TO SUSPEND PROCEDURAL SCHEDULE

OnSite Access Local, LLC (OnSite), filed an application on April 27, 2000, for a certificate of service authority to provide basic local exchange telecommunications services in the state of Missouri under 4 CSR 240-2.060. The Commission issued a notice directing interested parties to file applications to intervene no later than June 1, 2000. On June 6, 2000, the Commission granted intervention to Southwestern Bell Telephone Company (SWBT). OnSite filed a joint proposed procedural schedule on June 22, 2000. On June 28, 2000, the Commission issued an order adopting the proposed procedural schedule, which provided that direct testimony by the applicant would be due on October 16, 2000.

On October 16, 2000, OnSite filed a Motion to Suspend Procedural Schedule, noting that the parties anticipate that this matter can be resolved by stipulation. OnSite states that it has prepared the draft of a stipulation and will submit it to the parties for approval this week. OnSite believes that the matter will be resolved without the necessity of a hearing. As a result, OnSite

requests that the Commission suspend the procedural schedule for a period of 90 days; if a stipulation is not filed within that time, OnSite requests that the Commission then direct that another procedural schedule shall be filed. OnSite states that counsel for the Staff of the Commission, counsel for SWBT, and counsel for the Office of the Public Counsel have no objection to the request for a suspension of the procedural schedule.


The Commission has reviewed the October 16, 2000, Motion to Suspend Procedural Schedule, and finds that the request should be granted. However, instead of waiting for the expiration of the 90-day suspension period before ordering a second proposed procedural schedule to be filed, the Commission will direct that either a stipulation and agreement or a proposed procedural schedule shall be filed within 90 days of the effective date of this order.

IT IS THEREFORE ORDERED:

1. That the Motion to Suspend Procedural Schedule filed on October 16, 2000, is granted. The parties shall file either a stipulation and agreement or a proposed procedural schedule by January 29, 2001.

2. That this order shall become effective on October 29, 2000.
