

ORDER CANCELING CERTIFICATE

On July 12, 1999, the Staff of the Missouri Public Service Commission (Staff) filed a pleading asking the Commission to cancel the certificate of authority and tariffs of Strategic Telecom Systems, Inc. (STS). On August 11, 1999, Staff filed a substitute motion providing additional information. The Commission granted STS a certificate of service authority to provide intrastate interexchange telecommunications services in case number TA-97-412.

Staff states that STS did not file an annual report in 1997 as required by Sections 392.210 and 392.390.1, RSMo. In addition, the 1998 annual report form sent to STS was returned by the postal service as undeliverable. Staff also states that the Missouri Secretary of State's office administratively dissolved STS on August 28, 1997, due to STS's failure to file an annual report with that office.

The Commission has reviewed the motion and the official file and finds that the certificate of service authority and accompanying tariff to provide intrastate interexchange telecommunications services granted to STS in case number TA-97-412 shall be canceled.

IT IS THEREFORE ORDERED:

1. That the certificate of authority and tariffs granted in case number TA-97-412 to Strategic Telecom Systems, Inc. shall be canceled on September 3, 1999, unless otherwise ordered by the Commission.
2. That this order shall become effective on September 3, 1999.
3. That this case may be closed on September 7, 1999.
