ORDER DIRECTING FILING

On March 9, 2000, the Staff of the Missouri Public Service Commission (Staff) filed and its motion asking the Commission to cancel the certificate of authority and accompanying tariff of Digital One Plus, Inc. (Digital). Digital was originally granted a certificate of service authority by the Commission to provide intrastate interexchange telecommunications services on March 14, 1997, in Case Number TA-97-290.
