

**ORDER CANCELING TARIFF**

On March 9, 2000, the Staff of the Missouri Public Service Commission (Staff) filed a motion to open a case and cancel the certificate of service authority for Assisted Operator Services, Inc. (AOSI). The Commission granted Staff's motion on August 15, 2000, and canceled AOSI's certificate of service authority to provide intrastate interexchange telecommunications services.

Furthermore, the Commission will cancel the tariff granted to AOSI in Case No. TA-93-235.

**IT IS THEREFORE ORDERED:**

1. That the tariff granted to Assisted Operator Services, Inc., in Case No. TA-93-235 is canceled.
