

**GREELEY GAS COMPANY'S RESPONSE  
TO STAFF'S RECOMMENDATION**

COMES NOW Greeley Gas Company (hereinafter "Greeley" or "Company"), by and through its counsel, and states in response to Staff's Recommendation filed on May 1, 2000, and the Commission's Order Directing Response of May 5, 2000, as follows:

1. On May 1, 2000, the Commission Staff filed its recommendations in this docket, following its review of Company's filing in this matter. Staff recommended that the Commission issue an order requiring Greeley to adjust the ACA balance in its next ACA filing from \$17,541 over-recovery balance to \$82,244 over-recovery balance to reflect certain adjustments proposed by Staff.

2. On May 5, 2000, the Commission issued an order directing Company to respond to Staff's recommendations no later than June 5, 2000.

3. Company has reviewed Staff's recommendations and concurs with them. However, Company neither concurs with nor disputes the methodology utilized by Staff in reaching its recommendations.

WHEREFORE, Greeley Gas Company urges the Commission to issue an order approving the Staff's recommendation of May 1, 2000.


