On March 22, 2007, Timber Creek Sewer Company (Company) submitted a request for permanent increases in its current sewer rates to the Missouri Public Service Commission (Commission), under the provisions of the Commission's small company rate increase procedure.

By its request, the Company is seeking increases in its customer rates intended to generate an increase in its annual sewer operating revenues of \$120,000 (approximately 32.24%). The Company believes this increase in its operating revenues is necessary due to increases in utility plant and infrastructure investment; increases in operation and maintenance expenses; increases in the Commission's annual utility assessments; increases in the Department of Natural Resources' annual sewer discharge permit fees; and additional staff needed to support the business. In its request, the Company also requested certain changes to its service charges and connection fees, and recognized that changes to its general business practices, customer service practices and general tariff provisions, and the design of its customer rates, might occur. Set out at the end of this notice is a table that includes a comparison of the Company's current customer rates and the current rate increased by 32.24% and the requested changes in its service charges and connection fees. A monthly bill comparison is also shown.

In the near future, the Staff of the Public Service Commission (Commission Staff) will conduct an independent audit of the Company's books and records, and an investigation of the Company's business and system operations. Based upon that audit and investigation, the Commission Staff will develop its positions regarding the Company's requested increase in its annual operating revenues. Additionally, the Commission Staff will develop positions regarding the need for changes in the Company's service charges, connection fees, general tariff provisions, business operations and system operations, and in the design of the Company's customer rates.

The Office of the Public Counsel (OPC), a state agency responsible for representing the interests of utility consumers before the Commission, may also conduct its own audit and investigation, but at a minimum will review the results of the Commission Staff's audit and investigation.

Any customer who has questions or comments regarding the Company's rate increase request, or who has comments regarding recent service-related problems, should contact the Commission Staff and/or the OPC, within 30 days of the date of this notice. To do so, please use the mailing addresses, telephone numbers, fax numbers or e-mail addresses shown below, and please also include a reference to request number **QS-2007-0008**. As a part of their investigations into the Company's rate increase request, the Commission Staff and the OPC will review all customer comments they receive in response to this notice.

From the company's notice, we also understand they propose to double connection fees, permit/inspection fees, and re-inspection fees.

We appreciate that company investors expect a reasonable rate of return on their investment, but surely 116% increase in the span of three years exceeds this expectation.

Considering that our monthly water bill is only averaging \$23.00, the sewer fee is extremely excessive. In normal every day life the sewage use is 10% less usage than the water usage...how can we be asked to pay excessive sewer costs for private sewage transit. Our water is rural water, which we know is more expensive than water inside City Limits.

Knowing the owners who established and built all the homes in our neighborhood, this is just another get rich quick tactic.

The company's infrastructure is fairly new—the oldest sewer lines were built in 1995. These are not old lines that need frequent service, further raising questions about the rate increase request. I would like to have exact figures the company has submitted to justify the increase request:

We have checked with various other friends in the immediate areas (Platte City, Mo and Leavenworth, Ks) and much to our surprise, found their sewer rates several dollars less than what we are currently paying. We have enclosed copies of two-sewer bills for your review. It is difficult for us to understand how the sewer rates of these two friends can only be \$5.08 and \$10.91 a month and ours is going to be \$35.67 if this rate increase is approved. I am truly concerned about my home value decreasing because of what I believe will be a sewer rate that many prospective home buyers would not agree to if they were informed. How could I expect a homebuyer to agree to this rate when many of the current homeowners feel this increase is not justified!

While only our signatures are on this letter, we feel we represent several other homeowners in this neighborhood. While increases are necessary to survive in any business, we believe this rate increase is not justified based on the previous increase and the cost of operating this type of business.



Hunt Midwest Real Estate Development received an "Initial Customer Notice" from Timber Creek Sewer Company regarding its recent request to the Missouri Public Service Commission for permanent increases in its sewer rates. We are writing this letter as a representative of several developers who own substantial property within the Timber Creek Sewer service area. Furthermore, we represent many of the future customers that will be subject to the Timber Creek Sewer Company's rates.

We have not engaged in a detailed analysis of each of the rates proposed for increases by Timber Creek, but based upon our initial review we firmly object to the proposed increase for the service connection fee. Just 4 years ago, the Timber Creek Sewer Company's service connection fee was set at \$1,000 per home site. We were required to pay that fee prior to connecting a development to any sewer lines. For a typical 50-lot residential subdivision phase, those connection fees totaled \$50,000 to be paid by the developer at the time a plat was recorded which is well in advance of actual sewer usage.

In 2004, the Timber Creek Sewer Company raised the connection fee to \$1,600 per home site and now in 2007 proposes to dramatically increase that fee to \$3,200 per home site. At that level, the connection fee costs for a typical 50-lot residential

subdivision phase will total \$160,000. If this new connection fee is approved, we will see connection fees more than triple in cost over a 4-year period.

It is our position that this increase is unjust and unreasonable and will have a substantial negative impact on development in this area; and in general be detrimental to the public interest. In our estimation, the proposed connection fees are well above any reasonable cost and we have not been provided any justification for the rate increase.

As mentioned above, we have not examined each of the rates that the Timber Creek Sewer Company proposes to increase and may have objections to one or all in addition to the service connection fee proposal.

Our consolidated group requests that the Public Service Commission Staff and the Office of Public Counsel reject the Timber Creek Sewer Company's proposal to increase these rates, particularly the service connection fee. If the Timber Creek Sewer Company is intent upon this proposal, it should be part of a standard rate case in which Hunt Midwest and other parties may participate.

This letter is in response to request number QS-2007-0008.

The following concerns should be noted:

1. Pump rental and 75.00 dollar service fee for maintenance? Timber Creek Sewer charges 75.00 dollars per hour to service a pump that they choose to use in conjunction with their system. Now they want and additional 5.00 dollars a month rental fee for the existence of this pump to be used in accordance with that system. I am not aware of any other sub division in Platte City that uses a grinder pump. Additionally, the pump installed should be able to grind up feminine hygiene products which the current pumps are not able to do. Timber Creek Sewer has chosen to install a low end grinder pump and the customer is paying the price for that decision. I do not want to have to rent something (then pay a 75.00 dollar service fee when it breaks down) that in this day and age should be able to handle such things as feminine hygiene products and flushable baby wipes.

Question: Will home owners be able to select a high quality pump that will be required by the Timber Creek Sewer Company to be installed instead to the low end model they have selected to use? In addition, will the home owners own the grinder pump after so many years of rental payments and will Timber Creek Sewer be required to service that grinder pump after ownership is obtained by the property owner without an additional charge of 75.00 dollars to the homeowner?

With a rental fee and a service fee the consumer is paying the price for a company's decision to install a grinder pump system (a low quality one at that). When are they (Timber Creek Sewer) going to have to pay for the decisions that they have made as a company?

- 2 Every resident on our street has either had replacement or repair done to their grinder pump. With this replacement or repair each resident has received a service charge in the amount of 75.00 or 150.00 dollars from the Timber Creek Sewer Company. Some residents have even reported back up of the sewer into their basements do to the malfunction of the grinder pump that has resulted in damage to carpeting and/ or drywall.
- From prior visits to our property, Timber Creek Sewer Company employees informed the residents that Timber Creek Sewer Company was going to change out the current grinder pumps with different grinder pumps from another manufacturer. According to Timber Creek Sewer Company employees, Timber Creek Sewer Company has installed a below industry standard grinder pump. Timber Creek employees have reported on several occasions that Timber Creek Sewer Company is not satisfied with the current grinder pumps and plan to go with a new manufacturer of grinder pumps in the future. They anticipated replacing all current grinder pumps with new ones from the new manufacturer beginning spring of 2007.

To this day that switch of grinder pumps has not taken place.

It was explained to the homeowners that if the water level in the reservoir dropped below a certain level that the grinder pump would shut off automatically as a safety to the pump itself until the water level returned to a safe operational level. This built in operation could result in material (i.e. toilet paper) jamming the grinder mechanism due to the material not being fully ground-up when the water level dropped.

This automatic shut down of the grinder pump has resulted and will continue to result in back-ups into the customers basements because the pump has shut down and is not grinding...but definitely this shut down of the grinder pump will result in a service call to Timber Creek Sewer Company. They have to (let me repeat...THEY HAVE TO) come out and service the grinder pump because the pump can not restart itself. When the grinding mechanism automatically shuts off and becomes jammed by what's currently being ground, the system is not designed to back off and restart itself...it has to be done manually by a Timber Creek Company employee. So due to this drop in the water level (which there has not been given a clear explanation way this occurs) the automatic shut off is activated and to no fault of the home owner (they are just using their facilities), they have to make a service call to Tiber Creek Sewer Company. In making this call, the home owner will be guaranteed to receive a service charge form the Timber Creek Sewer Company to fill the reservoir (with water from the house of the home owner) and restart the grinder pump manually. This has already happened on several occasions.

5. Customers in our area are aware of stronger pumps that can handle such things as personal hygiene products and disposable baby wipes. Customers are also aware of pumps that can retract (turn count clockwise) when they become jammed and restart themselves. No need for the customer to make an unnecessary service call, ultimately resulting in a 75.00 charge when the water level drops, because these pumps can retract and restart itself.

Question: Why should the customer be charged a rental fee on a below industry level grinder pump and be charge a service fee for its maintenance when it fails to perform?

Please be advised that the rate increase request you commented upon is simply that, a request by the Company. A rate increase will not occur unless the Commission approves one, and that will not happen unless the Staff of the Commission has submitted a recommendation for approval of an increase to the Commission.

The Staff is currently auditing the Company's books and records to determine if it believes a rate increase is warranted. The Staff is also conducting reviews of the Company's service charges and connection fees, the Company's operation of its utility facilities, the Company's business operations and the Company's tariff provisions to see if any changes regarding those matters are warranted. When the Staff's audit and reviews are completed, the Staff will work with the Company, and the Office of the Public Counsel, in an attempt to reach an agreement regarding the Company's request.

As a customer of the Timber Creek Sewer Company, I feel the requested rate increase is excessive.

Until 2004, we paid \$16.50 a month for sewer service. That year the rate was increased to \$26.97. Now, just three years later, an increase to \$35.67 is being requested. By any reasonable analysis, this rate of increase is extreme, representing a whopping 116% increase over the original rate.

From the company's notice, we also understand they propose to double connection fees, permit/inspection fees, and re-inspection fees.

We appreciate that company investors expect a reasonable rate of return on their investment, but surely 116% increase in the span of three years exceeds this expectation.

The company's infrastructure is fairly new—the oldest sewer lines were built in 1995. These are not old lines that need frequent service, further raising questions about the rate increase request. I would like to have exact figures the company has submitted to justify the increase request:

- What are the increases in utility plant and infrastructure investment?
- What are the increases in operation and maintenance expenses?
- What are the increases in the Public Service Commission's annual utility assessments and DNR's annual sewer discharge permit fees?
- How many and what types of additional staff are needed to support the business?

As Missouri law dictates, I look forward to an aggressive, independent audit of the company's books and records by commission staff. Furthermore, because of the magnitude of this rate increase request, I strongly believe a local public hearing, where all facts, figures, income, and expenses can be presented publicly, is appropriate.

I would like to express my concern over the proposed rate increase by Timber Creek. I feel that a 32.24% rate increase is very excessive. If you include the additional \$5.00 charge for the grinder pump that makes the rate increase over 50%. I think a modest increase in the monthly charge would be understandable remember the cost of living increase is less than 3%. I also question the statement that the increase is due to utility plant and infrastructure investments. The infrastructure investment to Timber Creek Sewer Co. in Johnson Ridge was \$0.00. The developer paid Timber Creek Sewer Co. for all the equipment and installation for the entire system. As a customer of the Timber Creek Sewer Company, I feel the requested rate increase is excessive. I am asking that The Office of the Public Counsel conduct an audit and investigation of this rate increase.

I would like to have a map of the sewer system that goes through Timber Park Subdivision, the first subdivision where the sewer system was placed. Now all of the sewage water from Timber Creek Sewer Company that is to the north and east of our subdivision goes through our neighborhood.

Until 2003, we paid \$16.50 a month for sewer service. That year the rates were increased to \$26.97. Now, just four years later, an increase to \$35.67 is requested. According to my math, that is a 116% increase in four years.

I would like answers to the following questions:

- What are the increases in utility plant and infrastructure investment?
- What are the increases in operation and maintenance expenses?
- What are the increases in the Public Service Commission's annual utility assessments and DNR's annual sewer discharge permit fees?
- How many and what type of additional staff are needed to support the business?

I look forward to appearing at the public meeting to voice my concerns.
