NOTICE OF CORRECTION

On June 11, 1997, the Commission issued its Order Dismissing Petition in this case. The order contains an inaccuracy in a sentence describing the Outstate Calling Area (OCA) service, and a misstatement in the footnote attached to the sentence. The inaccuracy is found in the sentence located on page 7 of the order, third line from the top. The sentence currently reads as follows:

It [OCA] is available to customers in the MCA-2 exchanges of Springfield and to exchanges not within the MCA plan, although it cannot be used to reach exchanges within the MCA.

This sentence should be corrected to read as follows:

It [OCA] is available to customers in the MCA-2 exchanges of Springfield and to exchanges not within the MCA plan, although it cannot be used by customers in the MCA-2 exchanges to reach exchanges within the MCA.

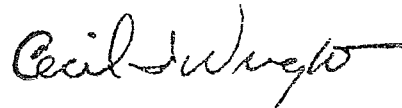
Footnote 3 of the Commission's order, which is attached to the above-referenced sentence, currently reads as follows:

Thus OCA can be used by residents of MCA-2 exchanges such as Elkland, Fordland, and Marshfield to call residents in Conway, Niangua, and Seymour, subject to the 23 mile limitation. However, residents of non-MCA exchanges such as Conway, Niangua, and Seymour can use OCA only to call residents in other non-MCA exchanges, also subject to the 23 mile limitation.

Footnote 3 should be corrected to read as follows:

Thus OCA can be used by residents of MCA-2 exchanges such as Elkland, Fordland, and Marshfield to call residents in non-MCA exchanges such as Conway, Niangua, and Seymour, subject to the 23 mile limitation. However, residents of MCA-2 exchanges may not use OCA as a substitute for MCA service to call exchanges within the MCA. In contrast, residents of non-MCA exchanges such as Conway, Niangua, and Seymour can use OCA to call residents in both MCA and non-MCA exchanges, subject to the 23 mile limitation.
