MOTION FOR EXTENSION OF TIME TO FILE TARIFF

COMES NOW Pathnet, Inc., ("Pathnet") and hereby requests an extension of time to file its Competitive Local Telecommunications Services Tariff. In support of its Motion, Pathnet states as follows:

- 1. Pathnet applied to the Missouri Public Service Commission ("Commission") on April 19, 2000, for a certificate of service authority to provide basic local telecommunications services in portions of the State of Missouri and to classify said service and company as competitive under Sections 392.420 .440 RSMo 1994, and Sections 392.410 and .450 RSMo Supp. 1999, the federal Telecommunications Act of 1996, and 4 CSR 240-2.060. Pathnet asked the Commission to classify it as a competitive company and waive certain statutes and rules as authorized by Sections 392.361 and 392.420. Pathnet is a Delaware corporation with principal offices located at 11720 Sunrise Valley Drive, Reston, Virginia 20191.
- 2. The Commission issued a notice and schedule of applicants on April 25, 2000, directing interested parties wishing to intervene to do so by May 25, 2000. On May 5, 2000, Southwestern Bell Telephone Company ("SWBT") filed its application to intervene which was granted on May 30, 2000. No other entity intervened.
- 3. The parties filed a Stipulation and Agreement ("Agreement") on July 10, 2000.
 The Staff of the Commission filed Suggestions in Support of the Stipulation and Agreement on July 11, 2000.

- 4. The Commission, on August 8, 2000, entered the Order Granting Pathnet a

 Certificate to Provide Basic Local Telecommunications Services with an effective date of August

 18, 2000 and ordered Pathnet to file a tariff within 30 days after the effective date of a

 Commission order approving an interconnection agreement that will allow Pathnet to provide services.
- 5. On October 16, 2000, Pathnet filed its Competitive Local Telecommunications Services Tariff ("Tariff") with a proposed effective date of November 30, 2000. After discussions with PSC Staff certain alterations were made to the proposed Tariff which were submitted on November 10, 2000.
- 6. On November 13, 2000, Counsel for Pathnet was informed that Staff wanted additional changes to the proposed Tariff which will require further work on the proposed Tariff and further discussions with the Staff which will not give Staff adequate time to review the proposed Tariff so that it can go into effect as of November 30, 2000.
- 7. Pathnet will need additional time to revise its proposed Tariff to satisfy the concerns of the Staff.

WHEREFORE, Pathnet, Inc., respectfully requests an extension of time to file its initial tariff no later than 3:00 PM on December 15, 2000.
