**REQUEST TO AMEND
EVALUATION, MEASUREMENT AND VERIFICATION SCHEDULE,
AND MOTION FOR EXPEDITED TREATMENT**

COMES NOW Union Electric Company d/b/a Ameren Missouri ("Ameren Missouri" or "Company") and submits to the Missouri Public Service Commission ("Commission") this *Request to Amend Evaluation, Measurement and Verification Schedule, and Motion for Expedited Treatment* ("Request"). In support of its Request, the Company states as follows:

1. On October 25, 2018, Ameren Missouri and numerous parties to this case submitted a *Stipulation and Agreement* for approval by the Commission. This *Stipulation and Agreement* included a revised *Ameren Missouri 2019-21 MEEIA Energy Efficiency Plan Report* ("Report") that addressed, among other things, a schedule addressing annual evaluation, measurement, and verification ("EM&V") reporting. On December 5, 2018, the Commission issued its *Order Approving Stipulation and Agreement and Granting Waivers*, which approved the *Stipulation and Agreement*

2. The EM&V schedule contained in the *Report* (at page 39) establishes time frames during which certain activities must be completed. Pursuant to those established time frames, the following activities and due dates remain in the current EM&V Reporting cycle for program year 2019 ("PY19"):

June 9	EM&V Contractor submits EM&V Final Report with final results for PY 2019
June 23	MPSC Auditor submits Final Report of Auditing PY2019 EM&V activities
June 30	Last day for stakeholders to submit change requests regarding impact evaluation results to Commission
July 7	Conference call regarding change request to impact evaluation if needed
July 21	Stakeholder group responses to impact change requests for PY19 are due to Commission
September 1	Evidentiary hearings for PY 2019 complete
October 1	Recommended date for Commission order resulting change requests for PY19

3. Given the activities and information provided according to the schedule to date, the EM&V contractor for PY19 has requested an additional nine days to complete a Final Report for PY19. Ameren Missouri has consulted with the Commission's Staff ("Staff"), who does not object to the extension so long as the remainder of the outlined activities are likewise extended. Accordingly, Ameren Missouri requests the schedule be amended as follows:

4. In accordance with 20 CSR 4240-2.080(14), Ameren Missouri requests expedited treatment of this matter because the next deadline – June 9 – is rapidly approaching. Accordingly, the Company requests a decision before that date, if possible. Granting this deadline extension in an expedited manner will allow the EM&V evaluator to complete a more thorough execution of its evaluation. There will be no negative impact on Ameren Missouri's customers or the general public if the Commission grants this request in an expedited fashion. The Company filed this request as soon as it could have been, given the pacing of the EM&V schedule contained in the *Stipulation and Agreement*. The parties, the EM&V evaluator, and the EM&V auditor have been working in good faith to meet all deadlines, and additional time is needed to ensure the resulting product is as well formulated as possible. .

¹ Because the ninth day falls on a Saturday, this date represents an eight-day extension.

WHEREFORE, for the reasons outlined above, Ameren Missouri requests the Commission decline to take preemptive action in this matter.
