PROPOSED DUE-DATE FOR STAFF REPORT AND MOTION FOR LEAVE

TO FILE PROCEDURAL SCHEDULE AT A LATER DATE

COMES NOW the Staff (Staff) of the Missouri Public Service Commission (Commission), on behalf of all parties, and for its proposal and motion in this matter respectfully states:

- 1. On July 13, 2000, the Commission issued its *Order Setting a Prehearing Conference and Directing Filing of Procedural Schedule*. In the *Order*, the Commission scheduled an early prehearing conference for August 2, 2000 at which it directed the parties to develop a procedural schedule, to be filed no later than August 9, 2000, and to clarify the issues in dispute.
- 2. The Commission issued a second order on July 26, 2000, in which it rescheduled the prehearing conference for August 7, 2000 and postponed the due date of the procedural schedule until August 14, 2000.
- 3. On August 3, 2000, the Commission issued its Order Denying Motion to Dismiss Complaint, Denying Motion for Reconsideration and Ordering Staff to Investigate in which it



directed Staff to investigate the complaint and file its report at a date to be determined by the parties at the prehearing conference. On the same date, the Commission filed its *Order Granting Motion for Continuance of Prehearing Conference* in which it rescheduled the prehearing for August 10, 2000 and postponed the due date for the proposed procedural schedule until August 17, 2000.

2. At the prehearing conference on August 10, 2000, the parties determined that more information is necessary before the issues can be clarified and before Staff can file its report. The parties concluded that additional time is needed to exchange information informally, issue data requests, and inspect Complainant's premises. Therefore, Staff, on behalf of the parties, requests that the Commission postpone the due date for the proposed procedural schedule and set the due date for the Staff report as follows:
