STATUS UPDATE

COMES NOW the Staff (Staff) of the Missouri Public Service Commission (Commission) and for its status update in this matter respectfully states:

- 1. On March 27, 2000, the Staff filed a motion recommending that the Commission cancel Touchtone Network, Inc.'s (Touchtone) certificate of service authority to provide intrastate interexchange telecommunications services, granted on January 3, 1995 in Case No. TA-95-123, and accompanying tariff. Staff gave notice of its motion via United States Mail to Mr. Ken Grossfield, President of Touchtone, and to Touchtone's attorney who filed the application. The United States Postal Service (USPS) returned the letter addressed to Mr. Grossfield as undeliverable.
- 2. On May 31, 2000, the Commission issued an order directing Staff to give notice of its motion to cancel Touchtone's certificate of service authority and tariff via certified United States Mail, return receipt requested.
- 3. In accordance with the Commission's order, Staff gave notice, via certified United States Mail return receipt requested, to Mr. Grossfield and to Touchtone's attorney of Staff's motion recommending the Commission cancel Touchtone's certificate of service authority and tariff. Subsequently, the USPS returned the receipts showing delivery of the letters to both Mr. Grossfield and Touchtone's attorney.
