STATUS UPDATE

COMES NOW the Staff ("Staff") of the Missouri Public Service Commission ("Commission") and for its status update in this matter respectfully states:

1. On April 27, 2000, the Staff filed a motion recommending that the Commission cancel Executech Services, Inc.'s ("Executech") certificate of service authority to provide shared tenant telecommunications services, granted on April 12, 1989 in Case No. TA-88-168, and accompanying tariff. Staff gave notice of its motion via United States Mail to Mr. Lucien Fouke, Jr., President of Executech, and to Executech's attorney who filed the application.

2. On June 2, 2000, the Commission issued an Order Directing New Notice in which it noted that the address for Executech on Staff's service list included an incorrect zip code, and directed Staff to resend notice of the motion with the corrected zip code to all parties.

3. In accordance with the procedure directed by the Commission in similar cases, Staff gave notice with the corrected zip code, via certified United States Mail return receipt requested, to Mr. Fouke and to Executech's attorney of Staff's motion recommending the Commission cancel Executech's certificate of service authority and tariff. Subsequently, the United States Postal Service ("USPS") returned the letter addressed to Mr. Fouke as undeliverable and marked "Unable to Forward." The USPS returned the receipt showing delivery of the letter addressed to Executech's attorney.

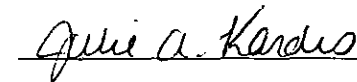
