**MOTION FOR LEAVE TO FILE
ANNUAL REPORT OUT OF TIME**

Comes now McDonald County Telephone Company ("McDonald County" or "Company") and for its Motion for Leave to File Annual Report Out-of-Time states to the Missouri Public Service Commission ("Commission") as follows:

1. Pursuant to 4 CSR 240-10.080(1), all public utilities subject to the jurisdiction of the Commission shall file an annual report on or before April 15. McDonald County Telephone is a telecommunications company subject to the jurisdiction of the Commission.

2. Since April 15 fell on a Saturday this year, McDonald County's accountant assumed that the date for filing the annual report would be extended to the next business day which was Monday, April 17.
