Comes now McDonald County Long Distance Company ("MCLD") and for its Request for Extension to Time to File Annual Report states to the Missouri Public Service Commission (Commission) as follows:

- 1. MCLD is a corporation organized and existing under the laws of the State of Missouri whose principal place of business is 704 N. Main Hwy W, P.O. Box 207, Pineville, Missouri 64856. MCLD is a "public utility" and a "telecommunications company" as those terms are defined in § 386.020 (42) and (51), RSMo Supp. 1999, subject to the control and jurisdiction of the Commission.
