

HOLWAY TELEPHONE COMPANY'S  
SECOND REQUEST FOR EXTENSION OF TIME TO  
FILE ANNUAL REPORT

Comes now Holway Telephone Company ("Holway") and for its Second Request for Extension to Time to File Annual Report states to the Missouri Public Service Commission (Commission) as follows:


1. Holway is a corporation organized and existing under the laws of the State of Missouri whose principal place of business is 208 Ash, P.O. Box 112, Maitland, Missouri 64466. Holway is a "public utility" and a "telecommunications company" as those terms are defined in § 386.020 (42) and (51), RSMo Supp. 1999, subject to the control and jurisdiction of the Commission.

2. As a Missouri regulated utility, Holway is required to file an annual report with the Commission each year by April 15. Although Holway has made a diligent effort to complete the report for submission by April 15, it was not possible for the company to file a complete and accurate report by that date. Due to the elimination of the Primary Toll Carrier Plan and the institution of dialing parity in its exchanges, there have been changes in the sources of the company's revenue and in its accounting which has caused the preparation of its annual report to be delayed. As a result, Holway requested an extension up to May 15, 2000 in which to complete and file its annual report.

3. Although Holway has been diligently trying to meet this May 15 deadline, it is unable to do so and it will require another fifteen (15) days to complete its Report.

Wherefore, Holway respectfully requests that the Commission grant its request for an extension of time up to May 30, 2000 to file its annual report and for any other relief appropriate in the circumstances.


