

**MOTION TO AMEND BY INTERLINEATION
THE FIRST PAGE OF THE APPLICATION**

COMES NOW OnFiber Carrier Services, Inc. ("OnFiber"), and hereby states as follows:

1. On April 28, 2000, OnFiber filed with the Commission its Application for authority to provide and/or resell basic local and local exchange and intrastate interexchange telecommunications services in the state of Missouri.

2. On June 8, 2000, the Commission entered a Notice of Deficiency and Order Directing Filing, ordering OnFiber to file by June 19, 2000, a pleading setting forth a specific reference to the statutory authority under which OnFiber is requesting relief, pursuant to 4 CSR 240-2.080(3).

3. Pursuant to the Commission's Order, OnFiber moves the Commission to amend by interlineation the first page of its application so that the first paragraph of the first page reads as follows:

OnFiber Carrier Services, Inc. ("OnFiber" or "Applicant") hereby requests authority, pursuant to §§392.410, 392.430, 392.440, and 392.450 RSMo, to operate as a local exchange, basic local exchange and interexchange provider of telecommunications services on a facilities and resale basis to customers throughout Missouri as hereinafter more specifically described.


4. OnFiber seeks to amend by interlineation the first page of the Petition to specifically reference §§392.410, 392.430, 392.440, and 392.450 RSMo, which are the statutory provisions under which OnFiber seeks relief from the Commission. OnFiber is simultaneously submitting a

sufficient number of the revised first page to replace the corresponding number of first pages on file with the Commission.

5. The amendments stated in paragraph 3 above are the only amendments to the first page of the Application. The remainder of the Application remains unchanged by this amendment.

WHEREFORE, OnFiber requests to amend by interlineation the first page of its Application for authority to provide and/or resell basic local and local exchange and intrastate interexchange telecommunications services in the state of Missouri.
