**ORDER GRANTING MOTION FOR CONTINUANCE OF
PREHEARING CONFERENCE**

By Order issued on July 13, 2000, the Commission scheduled a prehearing conference for August 2. On July 26, the Commission granted a motion for continuance filed by Southwestern Bell Telephone Company. The prehearing conference was rescheduled for August 7. On August 1, GTE Midwest Incorporated d/b/a Verizon Midwest (Verizon Midwest) filed a Motion for Continuance of the Prehearing Conference. Verizon Midwest indicates that its counsel will be unavailable on August 7 and requests that the hearing be rescheduled for August 10. The motion states that counsel for all other parties have indicated that they have no objection to rescheduling the prehearing conference.

After considering Verizon Midwest's motion, the Commission concludes that the prehearing scheduled for August 7 should rescheduled.
